**A RESOLUTION APPOINTING IRA A. COHEN, ESQ. AS JUDGE OF
THE MUNICIPAL COURT OF THE TOWNSHIP OF ROXBURY**

WHEREAS, the Township Council of the Township of Roxbury previously appointed Ira A. Cohen, Esq. as Municipal Court Judge for the Roxbury Municipal Court effective February 11, 2020, which term expires on February 10, 2023; and

WHEREAS, pursuant to the provisions of N.J.S.A. 2B:12-4, the Township Council is responsible for appointing the Municipal Court Judge; and

WHEREAS, the Township Council wishes to appoint Ira A. Cohen as Municipal Court Judge of the Township of Roxbury effective February 11, 2023.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Roxbury, in the County of Morris and State of New Jersey, that Ira A. Cohen, Esq., having offices at 3155 Route 10, Suite 211, Denville, New Jersey, 07834, is hereby appointed as Judge of the Municipal Court of the Township of Roxbury for a three-year term effective February 11, 2023, and expiring on February 10, 2026. Judge Cohen shall receive an annual salary of \$54,500.00.
